The position has a 1.5 year term left. Stacie Campbell seconded the motion. Motion carried and was unanimously approved by the Board.

We cannot spread out to the other rooms. We have to have at least 2 folks in a room. No real candles upstairs on in the prayer room. Need to ensure that we stick to rules of Circle Six.

Still have one vacancy which goes through 2016. Charlotte recommends on behalf of board for Phillip to serve remaining term of Bill Perryman through 2017.

MOTION: Dani Pool made the motion to accept the nomination of Phillip Vandiver to fulfill the 2 additional year term of Bill Perryman. Stacie Campbell seconded the motion. Motion carried and was unanimously approved by the Board.

Continue to pray for one additional clergy to serve on the Board.

The Slate for women to serve as a Board Rep for 2015 is still being worked on. The Nominating Committee currently has two names but is looking for two more. The slate will be present at next board meeting so that community can vote take place in September and October with results being announced at the combined November/December Community meeting.

The Nominating Committee has four people on the list who are not interested in being a Lay Director. There are four men on the list who need to work at least one more walk to be eligible to serve.

Six women are on the suggested Lay Director list. Although they are qualified, several are not active in HSE.

Lay Director training is in October so timing of the LD slate is critical.
