# **COMMUNICATIONS:** Rhett Lively

Sent new contract for web management.

- The database is actually maintained by Upper Room. The Registrar will continue to update the database pursuant to Walk registrations.
- The hosting will be at the current rate.
- Currently, Hi-Sky Emmaus pays 100/mth to Soli Deo Gloria Online which includes everything done on a monthly basis. Additionally, HSE pays a web server fee of \$100 (GeoSpectrum)/year + 12/year to NetworkSolutions for the registration of its domain name
- Updated costs and a new contract were submitted for website maintenance. Optional services were added at a charge:
  - Option to pay Soli Deo Gloria Online to:
    - 1. Producing the monthly newsletter (\$30/per hour: 3-4 hours/mth)

- 2. Operate visual media (per hour)
- 3. Mileage to/from Stanton will not charge mileage for in town.
- As of right now, Soli Deo Gloria Online is finished with the newsletter unless the Board approves the new contract.
- Summary of new costs: a typical walk month will now cost HSE \$175 for webmaster services + \$90 newsletter + \$40 to run AV at candlelight + \$25/hr to build PP for music teams and/or Community + .14 mile to/from Stanton = \$417 for a typical walk month
- Hosting Need to have a national provider
