The meeting was called to order at 6:01 p.m. Danny Bisbee led the Board and Guests in the Prayer to the Holy Spirit.

Thirteen Board members were present. The meeting proceeded with a quorum in attendance.

#### SCHOLARSHIP REQUESTS: STACIE CAMPBELL

**MOTION:** Danny Bisbee made the motion to accept the MW #219 scholarship request. Paula Yates seconded the motion. Motion carried and was unanimously approved by the Board.

#### FINANCIALS: STACIE CAMPBELL, Treasurer

- The 2015 insurance certificate was provided to Circle Six. This will cover all the Walks and Flights for 2015.
- Stacie met with Ken Arnold regarding the filing of Hi-Sky Emmaus' tax forms. The IRS Forms were filed Friday, January 13, 2015. Ken thinks HSE may have to pay penalties and fees for the late filing. Ken suggested that Martin Ramirez write a letter on behalf of HSE stating that the filings were late due to personal illness in hopes that the penalties and fees would be waived (or, at the very least, reduced).

ACTION ITEM: Martin Ramirez will call Ken Arnold to discuss the contents of the letter to the IRS on behalf of Hi-Sky Emmaus.

• February 2015 financials were presented.

**MOTION:** Charlotte Bosecker made the motion to accept the February 2015 financials without any revisions. Paula Yates seconded the motion. Motion carried and was unanimously approved by the Board.

## BOARD MINUTES: MELANIE HUDDLESTON, Secretary

Minutes for January 13<sup>th</sup> and January 20<sup>th</sup> board meetings were presented to the Board members via email prior to the meeting. No changes/revisions were made following the receipt of final meeting minutes.

**MOTION:** Danny Bisbee made the motion to accept the January 13, 2015 and January 20<sup>th</sup>, 2015 Meeting Minutes without any further changes. Steve Chilcoat seconded the motion. Motion carried and was unanimously approved by the Board.

# OLD BUSINESS

#### UPPER ROOM 2015 COVENANT: MARTIN RAMIREZ, CLD

The Upper Room Covenant which was signed by all 2015 Board Members was inadvertently signed on a 2014 form. Martin called the Upper Room to discuss how to proceed. Based on their recommendation, Martin struck-through 2014 and manually wrote 2015 at the top of the form. The Covenant with the revised date was provided to the Upper Room.

# TEAM SELECTION DISCUSSION: Howard Varley, Board Member

- We need to help the Lay Directors by not only selecting them earlier in the preceding year (with the goal being the end of the first quarter of the year but no later than the end of April), but also by helping them select their ALDs and Logistics Coordinator soon after they are confirmed as Lay Directors.
- Meetings between the ALDs and the Logistics Coordinator need to begin well in advance of the team meetings so that the ALDs can better manage both the Team Meetings and the Walks.

• The Board Reps need to work with the Lay Directors to ensure training schedules are set early and the Training Committee Chairperson is notified well in advance of the training session so that trainers can be notified and adjust their schedules accordingly.

## **NEW BUSINESS**

#### LATE PILGRIM REGISTRATION: MARTIN RAMIREZ, CLD

We continue to have problems with folks turning in Reservation Requests late. Two Walk Reservation requests were received today for MW #219 (which begins on Thursday, February 19<sup>th</sup>: one Reservation Request was received by via phone and there was no Reservation form or fee payment in hand; and, one Reservation Request included the completed Request Form but no fee payment. Note: The Reservation Request deadlines are printed on the instruction form which accompanies the Registration Request Form.

**MOTION:** Glenn Pipes made a motion to go forward with MW #219 based on the existing list of the 20 pilgrims whose sponsors returned the Reservation Requests and Payment prior to the 1-week deadline. Danny Bisbee seconded the motion. Motion carried and was unanimously approved by the Board.

## 2016 WALK SCHEDULE: MARTIN RAMIREZ, CLD

Circle Six has been in contact with Hi-Sky Emmaus to discuss Walk dates for 2016. Due to low attendance records and the fact that HSE has struggled for the past three plus years to fill at least one man's and one woman's walk, a lengthy discussion ensued as whether or not it was in the Community's best interest to cut 2 walks next year: 1 men's walk and 1 women's walk.
