Minutes for February board meetings were presented to the Board members via email prior to the meeting. No changes/revisions were made following the receipt of final meeting minutes.

**MOTION:** Stacie Campbell made the motion to accept the March 2015 Meeting Minutes without any further changes/revisions. Danny Bisbee seconded the motion. Motion carried and was unanimously approved by the Board.

## **NEW BUSINESS**

#### HSE BOARD WORK DAY: MARTIN RAMIREZ, CLD

Would like the Board to have a work day to ensure that we are all on the same page. Recommends that we Skype with Upper Room to have some guidance.

**<u>ACTION ITEM</u>**: Martin Ramirez will call the Upper Room to request a few dates when it would be convenient for a representative to Skype into our Saturday working meeting. Martin will let everyone know when the work day is scheduled.

#### 2016 WALK SCHEDULE: MARTIN RAMIREZ, CLD

During the March Board meeting, the Board discussed and voted on eliminating two Walks in 2016 due to the continued problems HSE has been experiencing the past 3 years filling Walks with enough Pilgrims. Several Board members have been having second thoughts and many felt the Board did not take enough time to pray and consider what was right for our Community. If we have fewer walks, it will take longer to train folks to work future walks and eventually be eligible to be a Lay Directory. Board members were asked to pray about the direction we should move in preparation for continued discussion at the April meeting. It takes 12 pilgrims and a full team to breakeven for a walk.

**MOTION:** Charlotte Bosecker made a motioned that the Community conduct 6 walks in 2016. Paula Yates seconded the motion. Motion carried with 12 Board members in Favor, 1 Board member Against and 1 Board member who Abstained from the vote.

### WALK REGISTRATION DEADLINES: HOWARD VARLEY, Board Member

• The Upper Room recommends that the registration due date for Walks should be two weeks prior to the start of the walk.

- The Board voted a few years ago to reduce the cutoff date to the Thursday prior to each walk and that HSE needed 20 pilgrims registered for the walk to make.
- This practice may cause folks to delay sending in applications because they may be viewing the lack of participation listed on the website, feel that the walk may not make and, therefore, do not send in registration request forms for their pilgrims. Additionally, it is recognized that this practice puts a bit of stress on sponsors who need to get letters, and may impact folks who provide personalized agape and both team members and pilgrims who registered well in advance as they may have requested to be off from their jobs and, if the walk does not make, may lose income.

**<u>ACTION ITEM</u>**: Martin Ramirez asked that this issue be tabled for further discussion in May regarding the time cutoff and the number of people required for a walk to make. Martin would like Board members to pray and seek direction from God on how to proceed.
